President's Remarks: Mary Jane Manners and Denise Burke- Royal Reporter lacked articles in the last issue. Mary Jane encouraged everyone to email herself, Denise or Myra Fleming after an event has been completed. This will help get the word out about events. You can even write up an article before the event to get them included in the issue. Please submit all articles for the next issue by early December (15th). All December events should be submitted by that time. We will have this issue completed for the new registration packet. It will be distributed the second week of January. Mrs. Dolan asked that the office be notified, specifically, Joanne, so they can plan ahead.

The Royals will be sending out emails for upcoming events. The January speaker will be the Development committee and they will discuss all new and upcoming events.
